



Below are several options that are available if you are in need of transportation assistance. For more information about each program, please use the contact information that is provided.

Insurance

Some insurance policies cover transportation assistance. Contact your insurance provider by calling the customer services number on your insurance card.

Medicaid

If you have Medicaid insurance, call your local Department of Job and Family Services to determine if you're eligible for transportation services.

Serves Allen, Auglaize, Hancock, Hardin, Mercer, Putnam and Van Wert counties.

The transportation call center is staffed by registered nurses and licensed social workers who provide free assessments of community transportation options for anyone who calls. The **FIND A RIDE** program sets up and pays for trips for eligible individuals who have no community options to meet their transportation needs.

Eligibility to individuals over 60, or individuals under 60 with a disability.

Road to Recovery

Every day thousands of cancer patients need a ride to treatment, but some may not have a way to get there.

The American Cancer Society Road To Recovery program provides transportation to and from treatment for people with cancer who do not have a ride or are unable to drive themselves.

How does the program work?

Volunteer drivers donate their time and the use of their cars so that patients can receive the life-saving treatments they need. If you or your loved one needs a ride to treatment, call the American Cancer Society at 1-800-227-2345 to be matched with a volunteer, or enter your zip code below to check for programs in your area.

Am I eligible?

Patients must be traveling to an appointment required to begin or complete cancer treatment, or to an appointment for complementary therapy during cancer treatment. Transportation cannot be provided for follow-up appointments after treatment has been completed.

Patients must be ambulatory, able to walk unassisted to and from the vehicle, or have an accompanying caregiver to assist. Patients under the age of 18 must be accompanied by a legally responsible adult such as a parent or caregiver. A 4 business day advance notice is required, not including the date transportation is needed.

LACCA COLT Transportation Services

WOCAP COLT Transportation Services serves Allen, Auglaize, Mercer, and Van Wert counties, providing transportation services for medical services. They operate 24 hours a day, and 7 days a week including holidays.

WOCAP CTS receives referrals from area agencies for transportation needs and clients call us directly to schedule transportation. WOCAP CTS self-pay billing is for self-pay clients who are not covered by another program and meet the Federal Poverty Guidelines.

An appointment with WOCAP CTS will determine income eligibility and whether or not there is a fee for transportation. If the total household income is below 125% of the Federal Poverty Guidelines, there will not be a fee for transportation services; if it is above, there will be a minimal fee. Payments are figured according to the Board approved Sliding Fee Scale. If you are in need of transportation services, please call LACCA at 419-584-1550 to schedule an appointment.
